Hazard Description:

Non-functioning Fire alarms and sprinkler system, severe understaffing of one officer per 70 inmates jeopardizes employee and inmate safety, frequent 24 hour shifts, no backup or support team in place for officers in event of emergency, officers assigned inside the facility fearful for life at work, excessive hours and failure to pay overtime timely, management threatens employees that complain about work place safety, prison is above maximum capacity (detainees and inmates are being commingled), holding cells have electrical and plumbing problems making them unsuitable, no professional radio system (officers are using push to talk cell phones with sporadic service), officers that complain fear retaliation, no protective equipment for contagious disease provided to employee (not even rubber gloves), Directors has no background, knowledge, experience or expertise in Corrections.

Adult Correctional Facility and associated buildings.
