- Everyone must provide valid identification and **hunters using firearms must have a valid firearms ID**
Forms of Valid Identification: (Military ID, Guam ID, Driver's License, Firearms ID)
- **"Special-No-Cost Hunting License"** available at registration sites and valid only for this Derby.
- Must wear hunter-orange, daytime fluorescent or "blaze" orange during event.
- **ALL** current Guam Hunting Regulations apply:
Guam Administrative Rules and Regulations, **Title 9 GAR, Div. 2, Ch. 11 Art. 1**
- Must display Pig Hunting Derby Vehicle Placard on dashboard of vehicle, placard to be provided.
- **NO DEER** harvesting while participating in the Pig Hunting Derby.
- Tiebreakers are determined by the time of the **last pig checked-in** (earliest time wins).
- Mandatory Check-Out and Check-In each day of Derby – Check Stations will be open at 4:30a.m.
- Derby **Start time is one-half hour before sunrise** and **End time is one-half hour after sunset**
(Pigs will not be accepted if entered after 8:00 p.m. and will not count toward the Derby).

- Runner is to follow all terms and agreement of the Derby.
- Only Runners registered with a Hunter may check pigs into the Check Station for a hunter still actively engaged in the hunt.
- A Runner may only accompany a Hunter into the field to assist with carrying the harvest out.
- Hunters may work in teams (for hauling and carrying out pigs) while in the field, but harvest will only be counted toward one participant.

*Important: Each participant must sign this form before participating in the Guam Pig Hunting Derby ("Activity"). **Read this Release and Waiver of Liability very carefully before you sign.** This Release and Waiver of Liability will remain effective 1 year from the date of signature.*

This Release and Waiver of Liability (the "Release") executed on this ____ day of _____, _____, by _____ (Participant), in favor of the Department of Agriculture (DoAg), the Government of Guam, and all of its comprising entities, their respective agencies, employees, officers, agents, contractors or assigns (hereinafter collectively referred to as "the Released Parties"). I, the participant hereby freely and voluntarily, without duress, execute this Release under the following terms:

- Waiver and Release.** I, the Participant release and forever discharge and hold harmless the Released Parties and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my participation in this Released Parties event. I, the Participant understand and acknowledge that this Release discharges the Released Parties from any liability or claim that Participant may have against the Released Parties with respect to bodily injury, personal injury, illness, death, or property damage that may result from participation in activities sponsored or supported by the Released Parties ("Activities"). It is also understood that the Released Parties does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.
- Insurance.** I, the Participant, understand that I expressly waive any such claim for compensation or liability on the part of Released Parties beyond what may be offered freely by the representative of the Released Parties in the event of such injury or medical expense.
- Medical Treatment.** I, the Participant, hereby release and forever discharge the Released Parties from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during participation in the Activity or any Activities with the DoAg.
- Assumption of Risk.** I, the Participant, understand that the Activity or Activities may include, but is not limited to, strenuous physical activity, walking in rugged terrain, heat exposure, local transportation to and from hiking sites. As the Participant, I hereby expressly assume the risk of injury or harm in these activities and release the Released Parties from all liability for injury, illness, death or property damage resulting from participation in any Activities with the DoAg.
- Photographic Release.** As the Participant, I grant and convey unto the Released Parties all right, title, and interest in any and all photographic images and video or audio recordings made by the Released Parties or other Participants during Activities with the DoAg.
- Other.** As the Participant, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of Guam in the United States of America, and that this Release shall be governed by and interpreted in accordance with the laws of the Territory of Guam. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not affect the validity of the remaining provisions of this Release, which shall continue to be enforceable.

BY SIGNING BELOW, I ACKNOWLEDGE THAT I AM AGE 18 OR OLDER, HAVE READ THIS AGREEMENT AND FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE, AND I INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

Release and Waiver of Liability (Continued)

IF PARTICIPANT IS UNDER 18, A PARENT OR LEGAL GUARDIAN MUST SIGN.

DO NOT LEAVE MINORS UNATTENDED. The Released Parties will not accept responsibility for any unattended minors. All minors under the age of 18 must be accompanied by a parent, legal guardian, or other responsible supervising adult, who must be present and accountable for any minor participants. Groups with minors must appoint at least one (1) responsible supervising adult per five (5) minors.

I am the parent or legal guardian of the above participant and he/she has my permission to participate in the Activity. I have read and agree to the provisions stated above for myself and the participant. Further, I understand and agree that the Government of Guam, the Department of Agriculture, and any other sponsors, coordinators, and organizers of the Activity are not responsible for supervision of minor participants and that if I allow the above minor to participate without my supervision, I assume all the risks from such participation.

BY SIGNING BELOW, I, THE PARTICIPANT MINOR'S PARENT AND/OR LEGAL GUARDIAN, UNDERSTAND THE NATURE OF THE ACTIVITY AND THE MINOR'S EXPERIENCE AND CAPABILITIES AND BELIEVE THE MINOR TO BE QUALIFIED, IN GOOD HEALTH, AND IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN SUCH ACTIVITY.
